NO.	CONTRACT PACKAGES	EXPLANATION/BREAKDOWN
1.	IFB NO. SBA/CSA/RB/001/15/16-Fuel and Lubricants	This line item will be used for the procurement of fuel and gasoline for all CSA vehicles and generators for its operations. A unit cost of US\$3.50 was used to derive at the quantity indicated in the plan. The Restricted Bidding method of procurement is proposed here whereby all capable suppliers of petroleum products will be invited to bid.
2.	IFB No. SBA/ CSA/RFQ/001/15/16-Workshops, Conference, Seminars (Hall Rental).	The CSA decided to hold four (4) workshops, Conference during the budget year 2015/2016. It will be used for Hall rental.  Hall Rental\$1,543.00.(\$1,543 x4= \$6,172.00 USD)
3.	IFB No. SBA/ CSA/RFQ/002/15/16- Workshops, Conference, Seminars ( Catering Services)	The CSA decided to hold four (4) workshops during the budget year 2015/2016. This contract package covers the budget line Workshops, Conference, Seminars. Catering Service\$2,407 @ least 120 participants. (\$2,407.00 X 4=\$9,628.00)
4.	IFB No. SBA/CSA/NCB/002/15/16-Entertainment Representation	This will include the purchase of refreshment items for Directors and other senior staffs of the Agency such as snacks, mineral water, soft drinks, power malts, super malt, Extra Juice, tea materials, etc.
